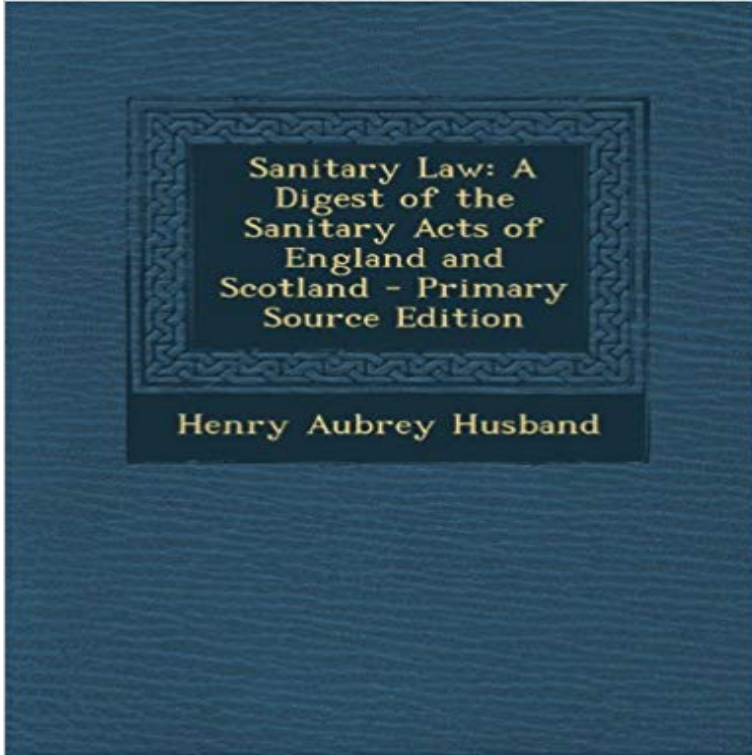


# Sanitary Law: A Digest of the Sanitary Acts of England and Scotland - Primary Source Edition
